RECITALS

- A. Pursuant to an Order of the Honourable Madam Justice K. Eidsvik of the Court of Queen's Bench of Alberta, Judicial District of Calgary (the "**Court**") dated October 29, 2019, Hardie & Kelly Inc. (as now substituted with BDO Canada Limited pursuant to an Order of the Court dated June 30, 2020) was appointed as the receiver (the "**Receiver**") of the undertakings, property and assets of Houston Oil and Gas Ltd. (the "**Debtor**").
- B. Pursuant to an Order of the Honourable Mr. Justice D.B. Nixon of the Court dated December 11, 2020, the limited discharge of the Receiver from and over (i) the approximately 1,114 well licenses, 937 pipeline licenses and 222 facilities licenses remaining with the estate and in the name of the Debtor, and (ii) the non-operating working interest of the Debtor in approximately 497 well or facilities licenses, which are included as Schedule "B" to that Order (the "**Remaining Properties**") was approved, with such limited discharge to take effect at 11:59 p.m. Mountain Time on the date of delivery by the Receiver to the Alberta Energy Regulator of a Receiver's certificate detailing the specific well licenses, pipeline licenses, facilities licenses and/or non-operating working interests included within the Remaining Properties from and over which the Receiver is seeking discharge (the "**Discharged Properties**").

WHEREFORE THE RECEIVER HEREBY CERTIFIES the following:

1. Care and custody of the Discharged Properties listed in Schedule "A" hereto has been transferred to the AER.
2. This Certificate was delivered by the Receiver to the AER on **January 7, 2021**.
