1. On January 13, 2020, BDO Canada Limited was appointed receiver (the "Receiver") of the assets, undertaking and properties (collectively, the "Property") of Bomet Polymer Inc. ("Bomet" or the "Company") pursuant to an Order of the Ontario Superior Court of Justice (the "Court").
2. The Receiver was appointed under section 101 of the Courts of Justice Act.
