## **INTRODUCTION**

1. On October 1, 2019 (the “**Bankruptcy Date**”), Giant Grosmont Petroleums Ltd. (“**Giant Grosmont**” or the “**Company**”) filed an assignment into bankruptcy (the “**Proceeding**”). Hardie & Kelly Inc. (“**H&K**”) was appointed as trustee of the bankrupt estate (the “**Trustee**”).
2. The first meeting of creditors (the “**FMOC**”) was held on October 21, 2019. There were no estate inspectors appointed.
3. On June 30, 2020, pursuant to a merger of H&K with BDO Canada Ltd. (“**BDO**”), the Court of Queen’s Bench of Alberta (the “**Court**”) granted an Order substituting H&K with BDO as the Trustee, with the effect that references to the Trustee herein shall refer to both H&K and BDO in such capacity
4. The purpose of this report (the “**First Report**”) is to provide the Court with background information in respect of the Company and an update as to the status of the Proceeding in contemplation of the Trustee’s application for advice and direction in relation to the funds that will be available for distribution at the conclusion of the Proceeding.

## **TERMS OF REFERENCE AND DISCLAIMER**

5. In preparing this First Report, the Trustee has relied upon unaudited financial information, discussions with former management of the Company, available books and records of the Company, information provided by and discussions with the Alberta Energy Regulator (the “**AER**”) and information provided by and discussions with the Trustee’s legal counsel (collectively referred to as the “**Information**”). The Trustee has not performed an audit, review or otherwise attempted to verify the accuracy or completeness of the Information.

## **COMPANY BACKGROUND**

6. The Company was a private company that had been in operation since 1977. Mr. Robert Watson and Ms. Joyce Wallace each held a 50% interest in the shares of the Company. In July 2019, Ms. Watson filed an assignment in bankruptcy such that her interest in the shares of the Company vested with her bankruptcy trustee.
7. As at the Bankruptcy Date, Mr. Watson was the sole director of Giant Grosmont and effectively served as the mind and management. The Company did not have any employees.
8. The Company does not hold any AER licenses or approvals.
9. As a result of holding minority non-operated working interests in 64 aging oil and gas properties (54 of the wells have been abandoned, the remaining 10 wells are reclamation certified), the Company received invoices for its proportionate share of costs incurred in respect of the oil and gas properties that it was unable to satisfy. Consequently, the Company made an assignment into bankruptcy.
10. As at the Bankruptcy Date, the Company effectively operated as a holding company with various assets including:
  - a. an investment in a private oil and gas company;
  - b. cash;
  - c. cash surrender value of a life insurance policy; and
  - d. a small amount of non-operated working interests and royalty interests pursuant to various agreements.

## **ACTIVITIES OF THE TRUSTEE**

11. The Trustee's activities have included, *inter alia*:
  - a. securing the remaining funds in the Company's bank account;
  - b. publishing notice of the FMOC in the *Calgary Herald*;
  - c. administering the claims process common place to a bankruptcy proceeding;

- d. arranging for the cancellation of a life insurance policy that the Company had taken out on the lives of Mr. Watson and Ms. Wallace and securing the available cash surrender value;
- e. liquidating the shares of the private oil and gas company;
- f. coordinating the sale of a small royalty interest back to the payor of the royalty;
- g. issuing letters (the “**License Update Letters**”) to parties whom the AER’s records reflect the Company as holding non-operated working interests in site licenses held by these parties that are not consistent with the Company’s records (the “**AER Reflected Interests**”), requesting that these parties update the AER’s records and remove Giant Grosmont as a working interest partner; and
- h. engaging in communications and discussions with the AER regarding the status of the proceedings and the AER’s position in respect of the Company’s proportionate share of the estimated future abandonment and reclamation costs (“**End-of-Life Obligations**”) associated with the Company’s remaining non-operated working interests and the Trustee’s position thereon.

## **CLAIMS**

- 12. The Trustee is not aware of the existence of any secured claims or claims that may be subject to a deemed trust.
- 13. There have only been two formal claims filed with the Trustee by creditors (the “**Unsecured Creditors**”) as follows:

14. The Trustee notes that based on the supporting documentation provided by Cenovus Energy Inc. (“**Cenovus**”), substantially all of its claim relates to Giant Grosmont’s proportionate share of abandonment, remediation and reclamation work undertaken by Cenovus.
15. In December 2021, in response to a 30-day notice to prove claims issued by the Trustee, the AER wrote to the Trustee advising that the AER’s records indicate that Giant Grosmont holds a non-operated working interest in 88 licenses issued by the AER (the “**AER Reflected Interests**”) and asking that the Trustee maintain funds pending the AER assessing its position with respect to the Company’s regulatory obligations. A copy of the letter from the AER is attached as **Appendix “A”** to this First Report (the “**AER Letter**”).
16. The only current obligation in relation to the AER that the Trustee is aware of, is the obligation to pay its share of suspension, abandonment, remediation, and reclamation costs as set out in section 30 of the *Oil and Gas Conservation Act* as referenced in the AER Letter. This is an obligation owed to the parties carrying out the work and constitutes an unsecured financial obligation.
17. The Trustee asked Mr. Watson to provide his comments in respect of the AER Reflected Interests. Mr. Watson advised the Trustee as follows:
  - a. 22 of the AER Reflected Interests were sold back in 2012 and 2013; however, given the age of the transactions, Mr. Watson no longer has any confirming documentation available; and
  - b. two of the AER Reflected Interests are errors.
18. As of the date of this First Report, the positive response to the License Update Letters requesting that they correct the AER’s records has been minimal with only one party updating the AER’s records to remove Giant Grosmont as a working interest participant in one licence. The Trustee is unable to amend the AER’s records, as it understands that only the Licensee and the AER are authorized to do so.

19. The AER recently provided the Trustee with its calculation of Giant Grosmont's estimated End-of-Life Obligations based on the AER Reflected Interests, a copy of which is attached as **Appendix "B"** to this First Report. As set out in Appendix "B", the AER estimates the Company's End-of-Life Obligations total \$57,588.60. The Trustee has no information as to what the Licensees anticipate any future costs to be or when they intend to carry out any work at the sites.
20. As set out in **Appendix "C"**, the Trustee has identified the AER's estimated End-of-Life Obligations in respect of the AER Reflected Interests that Mr. Watson disputes (bolded and highlighted) and notes that these total \$13,438.95, or approximately 23% of the AER's total Estimated End-of-Life Obligations.
21. In light of the Trustee having no additional information available, the Trustee does not intend to take any further steps to address any remaining discrepancies between the Company's records and the AER's records.

#### **STATEMENT OF RECEIPTS AND DISBURSEMENTS**

22. The Trustee's updated Statement of Receipts and Disbursements (the "**R&D**") is attached as **Appendix "D"** to this First Report. The R&D indicates that the Trustee has approximately \$117,000 available in its trust account as of April 22, 2022. The funds ultimately available for distribution by the Trustee (the "**Residual Funds**") will be net of the final billings of the Trustee and its legal counsel (the "**Final Professional Fees**").
23. As the administration of the Proceeding is effectively complete, in the ordinary course, the Trustee would simply distribute the available funds to the two proven creditors and proceed to its discharge. However, in light of the AER Letter, the Trustee deems it appropriate to make an application to seek this Honourable Court's advise as to whether the Trustee should proceed to distribute funds to the Unsecured Creditors.
24. The Trustee's position is that the Residual Funds should be distributed to the Unsecured Creditors in the ordinary course.

## **RECOMMENDATIONS**

25. At this time, the Trustee respectfully requests and recommends to this Honourable Court the granting of an Order:

- approving the distribution of the Residual Funds, after the satisfaction of the Final Professional Fees, to the Unsecured Creditors on a pro rata basis; and
- directing that the Trustee need not take any further steps with respect to any of Giant Grosmont's remaining non-operating working interests or with respect to the AER Reflected Interests.

**RE: Giant Grosmont Petroleums Ltd.**

Further to your notice requiring person to prove claim, the Alberta Energy Regulator (AER) has reviewed the Working Interest Participant (WIP) holdings for Giant Grosmont Petroleums Ltd. (Giant Grosmont) appearing in AER records to determine whether Giant Grosmont has regulatory obligations on AER licensed properties. As you know, under the *Oil & Gas Conservation Act* S.30 Giant Grosmont is responsible for their proportionate share of the suspension costs, abandonment costs, remediation costs and reclamation costs for a well and well site or facility and facility site where they hold a working interest.

The attached spreadsheet indicates AER's findings from the above-referenced review.

In circumstances where a WIP asserts a position that conflicts with the AER's WIP records on AER-regulated licences, the AER requests documentation in order to verify and adjust our records. Accordingly, if BDO finds that the WIP records for Giant Grosmont do not match what has been provided, the AER asks that BDO provide supporting documentation (eg. Purchase & Sale Agreements, etc.) explaining the discrepancy. Once in receipt of this additional documentation, the AER will review it, and if in agreement, amend our records to note the revised WIP interests.

Finally, whether in agreement with the WIP records or not, the AER asks BDO to confirm that any funds remaining will be held in trust so that the AER can evaluate its position with Giant Grosmont's regulatory obligations.
