Please be advised that on January 20, 2021, the Court of Queen's Bench of Alberta granted an Order authorizing and directing BDO Canada Limited ("BDO") in its capacity as Receiver and Manager of Houston Oil & Gas Ltd. ("Houston") to file an assignment in bankruptcy on behalf of Houston.
