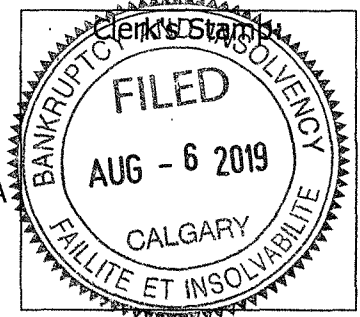

CONSENT ORDER

UPON THE APPLICATION of the Applicant, CWC Energy Services Corp. (**CWC**); AND UPON HEARING submissions from counsel for CWC; AND UPON noting consent of counsel for Hardy & Kelly Inc. (the **Trustee**), Trustee of the Proposal of OAN Resources Ltd. (**OAN**) and counsel for OAN; IT IS HEREBY ORDERED THAT:

1. The stay of proceedings imposed by the *Bankruptcy and Insolvency Act*, R.S.C. 1985 c. B-3 (the "**BIA**") is lifted *nunc pro tunc* to permit the Builders' Liens registered by CWC as instrument nos. 1901791 and 1901792 and to remain registered against OAN's well sites and is temporarily lifted to permit the filing by CWC of a Statement of Claim and

Certificate of *Lis Pendens* to secure CWC's Builders' Liens pursuant to section 69.4 of the BIA.

- 2. CWC may not take any other steps to enforce its Builders' Liens without further order of this Court while the stay imposed by the BIA is still in force.
- 3. There shall be no costs of this Order.




